By directions, this is 10 inform that, your request for renewal for registration of Material Testing Laboratory of M/s. Universal Testing Lab with MCGM, situated at Unit No. 14/109, Ground Floor, Unnat Nagar-4, CTS No.01, Opp.Azad Maidan, M.G.,Road, Goregaon (W) is considered by this office & the said laboratory is registered with this office up to 30.06.2023. However, the said laboratory is initially registered up to 13.08.2022 since, Shops & Establishment license is valid up to 13.08.2022.

During this period, you are permitted to carry out the mechanical testing of AAC Block, Bitumen, Bituminous Mix, Bricks, Cement, Coarse Aggregates, Concrete Beam, Concrete Cube, Core /Cylinder, Cube, Fine Aggregates, Fly Ash, GSB/W/MM/WBM, Paver Block, Steel,

Rock & Soil as per the Accreditation certificate granted by 'NABL', subject to following conditions.

- 1) The laboratory shall be maintained in good working condition for entire registration period.
- 2) The laboratory owners should give top priority to M.C.G.M. works. If failure is noticed in this respect, the laboratory will be de-registered.
- 3) Whenever the testing is carried out for Municipal works, laboratory owner's representative shall show all tests at laboratory, if desired by the visiting staff from Municipal Corporation of Greater Mumbai.
- 4) The laboratory shall be freely allowed for inspection to the visiting staff of Municipal Corporation of Greater Mumbai, as well as allow the MCGM staff to witness the testing, if required by the said MCGM staff.
- 5) The laboratory owner shall follow all instructions given to them from time to time by M.C.G.M.
- 6) The laboratory owner shall apply for renewal anytime before the expiry of this registration along with all the requirements of renewal of registration.
- 7) The instruments shall be got calibrated as per the requirement & certificate to that effect shall be available for inspection of visiting staff of MCGM.
- 8) The laboratory shall always be equipped with all the accessories submitted for registration. Failure to comply with the same will attract penal action along with deregistration of the firm.
- 9) The laboratory owner shall have minimum one Quality control Civil Engineer in the laboratory with adequate number of laboratory technicians. The Laboratory Engineer shall be experienced & well conversant with the concrete related testing & quality control.
- 10) The copies of test results shall be delivered in the respective Divisional offices of Roads Deptt./Ward Offices/ Any M.C.G.M. offices within a period of 7 days. If a test result is asked in duplicate by M.C.G.M., the same shall be provided within a period of 7 days.
- 11) Registers showing test conducted and result obtained for Municipal works shall be maintained & kept in the laboratory.

- 14) M.C.G.M. reserves the right to increase security deposit amount as and when required in future and the same shall be paid when informed.
- 15) The CCTV provided in the area of testing laboratory shall be kept in working condition during the registration period, and the feed (Recorded data) shall be preserved till the end of renewal of registration period and if required, it shall be made available for inspection to any visiting officer of MCGM, during the registration period.
- 16) This permission gives no right to run the material testing laboratory upon land, which is not the property of the laboratory owner and onus of running the laboratory on own/ leased/ rented land, lies solely on the owner.
- 17) The laboratory owner shall obtain all the prevailing necessary statutory permission / Licenses, their renewals/ re validations etc. from various Govt. / Semi Govt. /M.C.G.M. authorities applicable to the laboratory, under various prevailing Acts and the conditions stipulated therein shall be duly complied with. The laboratory owner shall be solely responsible for the consequences arising due to the operations of the laboratory without obtaining said permissions.

- 18) For non-compliance of the above conditions action deemed fit such as de-registration of laboratory, forfeiture of security deposit etc. will be initiated against the owner. Further, if there are any violations of conditions imposed by various Government authorities or if there is any legal litigation of environmental damage, the sole responsibility of the same lies with the lab owner.
- 19) MCGM reserves the right to forfeit the security deposit paid by you in case of violation of above conditions.
- 20) Please note that the renewal of registration of laboratory is valid up to 13.08.2022 only as the Shops & Establishment license is valid up to 13.08.2022. The applicant shall submit the copy of renewal of Shops & Establishment License beyond 13.08.2022 in time and on receipt of the same, renewal of registration will be further extended up to 27.09.2022 as the Accreditation certificate granted by NABL is valid up to 27.09.2022. The applicant shall submit the copy of further re validation of Accreditation certificate granted by NABL beyond 27.09.2022 in time, and on receipt of the same, renewal of registration will be further extended up to 30.06.2023.
- 21) In case the applicant fails to submit requisite documents in stipulated time as mention above, renewal of registration of material testing laboratory will be further extended up to 30.06.2023 from the date of submission of the copies of requisite documents stated above.
